## State licensing info (updated: 6/5/2019)

There are currently 11 states with laboratory personnel licensure (California, Florida, Georgia, Hawaii, Louisiana, Montana, New York, North Dakota, Tennessee, West Virginia). Puerto Rico also has licensure. The components of the law vary state-to-state, but usually includes an annual licensing fee (some are biannual), a provision for continuing education, a minimum education and professional competency requirements.

If a Medical Laboratory Scientist (MLS) or Medical Laboratory Technician (MLT) plans to locate in a state with licensure, that state should be contacted for specific information relative to that state's laboratory practice act. This contact should be made as early as possible after the location decision has been made. Most states (except California) require documentation of certification from an acceptable certification agency. Other things to expect are fingerprinting (Louisiana, possibly other states), documentation of certification, and documentation of education, training, and competency. Check with the state regarding trainee licenses or other requirements for new graduates without a valid license in that state.

A limited permit authorizes an individual who has met all requirements for licensure as a cytotechnologist or certified histological technician, except the licensing examination, to practice as a cytotechnologist or certified histological technician under the general supervision of the director of a clinical laboratory.

The limited permit is valid for one year. The permit may be extended for one additional year if the applicant can document good cause, such as a specific physical or mental disability certified by an appropriate healthcare professional or other good cause which, in the judgment of the Department, made it impossible for the applicant to complete the examination required for licensure.

You may apply for a limited permit by submitting the Application for Limited Permit (Form 5) and limited permit fee of \$50 at the same time or any time after you submit your Application for Licensure (Form 1), licensure and first registration fee of \$371, and evidence of satisfactory education.

**NOTE:** Under the general supervision of the director of a clinical laboratory means that the permit holder must be supervised by a director of a clinical laboratory who serves the laboratory full-time, or on a regular part-time basis; ensures the supervision of the technical performance of the permit holder, and is readily available for consultation with the permit holder, as needed; and is responsible for the performance and findings of all tests carried out by the permit holder, either by directly overseeing the testing, or by delegating the responsibility to authorized qualified supervisors who are on site in the laboratory.
